

THE BUSINESS OF SELF-CARE & LIFE ENRICHMENT

By 2026, the self-care industry will have an estimated value of \$13 Billion.

Soar Aerial Fitness opened in Summer 2022 after an extensive re-imagination of the space in Pottstown's New York Plaza. Its signature Aerial Yoga brings an unmatched playfulness and freedom to traditional fitness helping create a sense of community and empowerment. The studio also offers Zumba, Kickboxing, and other forms of Yoga. The Second Nest Holistic Healing Spa opened in Fall 2022, after a major renovation of this 1865 building as a holistic healing center with a team of massage therapists, estheticians, nurse practitioners, reiki masters, and more. Gypsy Dreaming & Counting Stars opened after a 2-month long renovation as a place for unity & expression, crystal collectors, metaphysical, healing, and spiritual needs, as well as hand-made items from dozens of artists. A small lounge, library, and workshop studio complete the space. High Street Music Company (HSMC) was established in 2006, with its' primary mission to preserve the integrity and prosperity of cultural arts within the Pottstown community, raise awareness of their social and educational importance, and their impact on the quality of life. HSMC offers private music lessons as well as audio production services. In Fall 2022, HSMC re-opened with a fresh modern design following flood damage. **Downtown Records** experienced a rebirth in Fall 2022, under new ownership, after operating over 50+ years in the same location. With a unique, vintage vibe, collectors and music lovers visit from around the region to appreciate this classic, timeless store. **Keystone Running & Walking** relocated their second store (the original is located in Allentown, PA) from Chester County to High & Hanover Streets in late 2022. It is a fresh, bright, modern store, featuring a life-size mural of an iconic High Street, that also hosts regular run groups and boasts the latest technology and equipment to capture 3-D imaging of the foot. Not just for runners, they also work closely with physicians and podiatrists to identify footwear solutions for patients. ArtFusion 19464 is a colorful and inviting nonprofit community art center that promotes education through arts and culture in a variety of programs, classes, gallery exhibits, and community partnerships. The Center's mission is to provide opportunities for communities to experience the visual arts in an environment of encouragement and dignity. After over a decade on High Street, the Center re-located in 2017 to a re-imagined, mixed-use, 100-year-old building that housed a former T-shirt Factory and furniture warehouse.
















THE WORK OF CONNECTING

Pottstown is the place to enjoy biking, kayaking and canoes with direct access to the Schuylkill River Trail's 120 miles. Pottstown plays host to thousands of visitors each year to enjoy annual community celebrations, national and international events, as well as seasonal activities.

2022 RECAP



L'oe Show was a one-of-a-kind, first-time-in-Pottstown car show held during Labor Day weekend 2022. Spanning across 4 days, this Audi/Volkswagen/Porsche show built upon the monthly car shows held Downtown from April through October. Over 300 cars from the U.S. and Canada, were displayed around the Downtown, flanked by multiple pop-up shops on High Street. From concept and prototype cars flown in from Germany, to a new car unveiling, this event offered free spectator admission, family-friendly entertainment, and bustling activity at Pottstown's beer gardens, restaurants, bars, eateries, and breweries.



Take-it-Outdoors Adventures brought a summer of pedal and paddling to Pottstown with its mission to connect people to the Schuylkill River Watershed after relocating from Chester County to Pottstown's Riverfront Park in Spring 2022. Founded in 2009, they offer kayak/canoe rentals, shuttles, group events, guided trips, education programs, and free bike share, in partnership with Schuylkill River Greenways National Heritage Area. With their new location situated in Riverfront Park, outdoor enthusiasts can enjoy the Park's 120 acres, as well as the Schuylkill River Greenways NHA River of Revolutions Visitor Center.



In June 2022, **Amtrak Thruway** began a luxury bus service linking Reading, Pottstown, and Philadelphia. With an affordable fare, luxury amenities such as wifi and an on-board restroom, travelers can ride in comfortable style to Philadelphia's 30th Street station. This transportation amenity creates easy access within the region, which ultimately creates appeal for businesses considering relocating to Pottstown, as it generates connectivity to other cities in the Northeast, including New York City and Washington DC.



In the summer of 2022 the Borough of Pottstown welcomed the **30th Annual Pottstown Volleyball Rumble** to Memorial Park, where nearly 4,300 volleyball players traveled from all over the Country to compete for 4 days. The First Pottstown Rumble Volleyball Tournament was held in 1991, and the event has grown into a four-day event with over 200 nets, 5 fields of play, a beer garden, music, and food.

WHAT'S OLD IS NEW AGAIN... AND BACK ON THE TAX ROLLS

Land banking is a tool, enabled by state legislation, to help communities combat the problems associated with blighted, abandoned, tax-delinquent, and vacant properties. These properties destabilize communities, create fire and safety hazards, drive down property values, and drain local tax dollars. PAED acts as the Administrator of Pottstown's Land Bank, whose mission is to return these properties into productive use through a unified, predictable, and transparent process. PAED works on behalf of the Land Bank to acquire the title, eliminate the liabilities, including tax liens and claims, and then facilitates the transfer of the properties to new, responsible owners in a transparent manner for use and development consistent with local plans and priorities.



ABOUT PAED

We are a 501c3 non-profit organization, originally formed as Pottstown Area Industrial Development (PAID) in 1965. PAED's mission is to promote commercial and industrial development in Pottstown, Pennsylvania. PAED provides services to businesses and organizations seeking to invest, expand or relocate, including assistance with site selection, commercial and industrial real estate development, access to resources, and workforce development. PAED's efforts stimulate investment, which helps maintain and enhance the tax base, retains and creates job opportunities, and restores, utilizes or removes under-utilized buildings.


